

DEAR EVAN HANSEN - PHOTO RELEASE (THE "RELEASE")

In consideration of my photo being evaluated and considered for use, I hereby grant Ed Mirvish Enterprises Ltd., Autumn Smile US Tour Limited Liability Company, Autumn Smile Broadway Limited Liability Company, all other persons involved in the development or operation of the photo program and/or the musical titled Dear Evan Hansen (the "Play"), their agencies, parent companies, affiliates, subsidiaries, principals, managers, officers, directors, employees, and the successors, assigns, agents and licensees of each of the foregoing, (collectively, and individually, the "Company") the non-exclusive, irrevocable license to use, modify, publish, publicly display, exhibit, alter, edit, copy and otherwise exploit and sublicense the photo I am submitting (the "Photo"), any copyright or other intellectual property or other property right contained therein, and my image and likeness and any other image and likeness contained therein (collectively, the "Materials"), in whole or in part, worldwide, in perpetuity, for commercial and non-commercial purposes of any kind or nature relating to the Play, in any form and/or media now known or hereafter devised, without payment or credit (collectively, the "Use"). Without limiting the generality of the foregoing, I understand that the Use shall include the Company's right to use the Materials in the official poster(s) of the Play, on stage during live performances of the Play, in and around any theatre where the Play is being presented (the "Theatre"), on the Internet (including, without limitation, the Company's website and third party websites) and other electronic means for social media, editorial, advertising and marketing purposes, which may or may not be monetized, directly and indirectly in connection with the Play; in television, film, and other audio only and audio/visual media; and in print for editorial, marketing, advertising and other purposes; and may be used for commercial and merchandise purposes, which may include but are not limited to, public display outside and inside of the Theatre, display onstage and for the general production and marketing purposes of the Company with respect to the Play. I hereby waive any right to inspect or approve any Use of the Materials by the Company, and any right to receive any credit, acknowledgment, royalties, compensation or other benefit (monetary or otherwise) arising out of or related to such Use. I acknowledge that I will have no personal interest or property right in the Materials as used by the Company at any time, and that the Company will retain all applicable interest and legal rights in the Materials. I hereby release the Company from and against all liability arising out of the Use of the Materials. I hereby represent and warrant that I am at least 13 years of age; that if I am under 18 years of age, my parent or legal guardian has signed and agreed to the terms herein; that I (or my parent or legal guardian, as applicable) own and control all of the rights being granted herein (including, without limitation, with respect to the Photo and any likenesses and any intellectual property contained therein); that I (or my parent or legal guardian, as applicable) have the sole right, power and authority to grant such rights to the Company and that no permission from any third party is required; that the exercise of the rights being granted herein does not and shall not infringe upon or violate the rights (including, without limitation, any copyright, trademark, moral right, right to be free from libel, slander, defamation or invasion of the right of privacy or publicity, or other proprietary right or interest of any kind or nature) of any third party and shall not result in any liability to the Company; that the Materials and the rights granted herein are and shall be free and clear of any lien, claim or encumbrance; and that my own use and display of the Photo shall be strictly limited to non-commercial uses only. I (or my parent or legal guardian, as applicable) hereby agree to indemnify, defend and hold harmless the Company against any claim (in law or equity), loss, damages, liability, cost or expense (including, without limitation, attorneys' fees) that the Company may suffer by reason of any third-party claims arising out of the breach of any of the foregoing representations and warranties.
